1. Access to discounts for the catering service

1.1. Recipients

They can access ARDIS catering services:

- (a) students at the University of Trieste and the University of Udine, enrolled in
- 1. bachelor's degree courses, master's degree courses, single-cycle master's degree courses;
- 2. specialization courses;
- 3. doctoral courses;
- 4. active training placement courses
- 5. per semester "filter" of single-cycle master's degree courses belonging to one of the classes LM-41, LM-
- 42, LM-46 at the academic year. 2025-26;
- 6. to the second semester of single-cycle master's degree courses belonging to one of the classes LM-41, LM-42, LM-46 or to the second semester of "related courses" for the academic year. 2025-26;
- (b) the students of the Conservatory of Music "G. Tartini" of Trieste and the "J" Conservatory of Music. Tomadini" from Udine registered at:
- 1. courses of the first level upper three-year period;
- 2. courses of the two-year level II specialist course.
- (c) students enrolled in courses of the ITS Foundations. Academies activated in the FVG region.
- (d) the students of the Academy of Fine Arts "GB. Tiepolo" of Udine registered
- 1) to the first and second level academic diploma courses in "Graphic Design for business"
- 2) to the first-level diploma courses in "Painting" and "Interior architecture and design"
- (e) i "fellows" of the University of Trieste, the University of Udine and the Institutions research audiences
- (f) students enrolled in a PhD course or a master's degree at the International School Superior of Advanced Studies (SISSA) of Trieste
- (g) Erasmus incoming students and students participating in international exchange projects
- (h) students from abroad, participating in intensive Italian language courses activated by the Refuges.

1.2 Access methods

Access to the canteen points is via the app "bookAmeal" which can be downloaded on all Android and Ios devices, in mode "Canteen card". In some catering outlets, meal reservations may be required with simultaneous payment; of this will be given adequate communication on the ARDIS website.

1.3.1 Rates

ARDIS automatically assigns the rate relating to the € 5.80 range to all students.

The student has the right to access the above rate for one meal for lunch and one for dinner.

Students enrolled in universities, conservatories and ITS foundations. Academy, at the Academy of Fine Arts Tiepolo and SISSA can apply online to request a further reduction in the feeaforementioned by selecting "reduced rate canteen service". These students must enter in the online application the data relating to the ISEE certification for subsidized benefits for the right to university study referring tovalid student.

1.3.2 For applications completed from July to December 2025 it will be necessary to enter the protocol numberrelated to the ISEE for subsidized benefits for the right to university education valid in 2025; as of 1°

January 2026 the tariff reduction can be requested by accessing online services by entering the number of protocol relating to the ISEE for subsidized benefits for the right to university education valid in 2026.

1.3.3 It should be noted that students enrolled in Conservatories and ITS Foundations. Academy, at the Academy of Fine Arts Tiepolo and SISSA must still access the ARDIS online services and fill in the data section personal data to obtain the qualification to use catering services. Students enrolled in courses doctorates (residents or non-residents of Italy) can opt for the different constitution of the family unit for access to benefits in application of Article 8 (4) of Prime Ministerial Decree No 159/2013 as amended and integrations.

Note: the breakfast service is also active at the Central University Canteen of Trieste. The related rates they will be published later on the www.ardis.fvg.it website.

The prices indicated in the table refer to the entire meal. The reduced meal is activated for all groups of income and is only provided at some canteen points. The relevant rates will be published later on the ARDIS website.

Students who have an active fee reduction application referring to the 2024/2025 academic year maintain the rate in force for said academic year. The concessionary fee required for the 2025/2026 academic year will be activated from 1° January 2026 and will be valid until 31 December 2026. The exception is students enrolled in the first year and students who have not activated the fee reduction application referring to the 2024/2025 academic year, for said types of students the discounted rate will be activated within 35 days from the date of online completion of the demand for tariff reduction. From the day following the day of inclusion in the online application of ISEE protocol number you can check, within your own reserved area in "student desk" in the section "Inps income assessed" the outcome of the automated extraction from the Inps database. For students with ISEE equalized by income/assets or nucleus abroad. Ardis periodically acquires parified ISEEs transmitted by affiliated CAFs.

Students eligible for the Ardis scholarship access the canteen service at a rate of €2.50.

Students who already have a degree and who enroll in a degree course at the same or lower level they access the catering service at the third-tier rate of \in 5.80. At the rate of \in 5.80 can benefit of the university canteen service, for the first three years of a single-cycle master's degree, students already in possession of a three-year degree. For subsequent years of enrollment in the same course the rate will be applied payable under ISEE. Students with disabilities in accordance with article 3, paragraph 1, of the Act of 5 February 1992, n. 104, or with disability equal to or greater than 66%, exempt from paying the regional tax for the right to university study, they always access the catering service at the canteen rate of \in 2.50. For the students participating in incoming international mobility programs or for those coming from from abroad, participants in intensive Italian language courses, a rate of \in 6.00 is applied.

The users listed below access the canteen service at the rate that guarantees coverage of the cost of the meal which, on the date of approval of this notice, depending on the refreshment points:

- students with incomplete enrollment procedures;
- students taking single courses;
- students from the University of Trieste and the University of Udine enrolled in first and second level master's degrees;
- students enrolled in training courses for which there is no payment of the regional fee for entitlement to university study;
- teaching and non-teaching staff of the University of Trieste and Udine, to the teaching staff of Conservatories and the GB Academy of Fine Arts. Tiepolo;
- ARDIS staff and staff of the Regional Administration and other regional bodies;
- participants in conferences, seminars and study activities, masters who do not pay the regional fee for the right to university study;
- the "scholarships" of the University of Trieste, the University of Udine and the public bodies of research
- additional recipients of the interventions for the right to university education referred to in Art. 4, c.2 of the LR. 21/2014;
- any other users authorized by ARDIS.
